Founded in 1988, Hosting Solutions and Library Consulting (HSLC) is a 501 (c) (3) non- profit organization rooted in its mission to promote information and resource sharing among libraries, particularly in Pennsylvania. With this not-for-profit mission, HSLC is uniquely positioned to advance solutions that leverage public funds into strategic initiatives.

Work Performed

Since 1992, HSLC has provided services in a variety of areas to the Office of Commonwealth Libraries and the Pennsylvania Department of Education, and these currently include the Access PA and POWER Library programs. As a non-profit partner to the Office of Commonwealth Libraries, HSLC is focused on promoting statewide technology initiatives as expressed and endorsed by the Deputy Secretary of Education.

HSLC is entrusted to centrally coordinate, manage and support the numerous statewide library services of ACCESS PENNSYLVANIA and the POWER Library, while remaining flexible and responsive to the needs of Pennsylvania libraries and the Office of Commonwealth Libraries.


In addition to its work on behalf of the Office of Commonwealth Libraries, HSLC supports other institutions with technology services, such as website hosting.

2022-2023

With a staff of 13 FTEs, HSLC spent the vast majority of its time during the year fulfilling the deliverables associated with hosting and administering the POWER Library. These services include but are not limited to: maintaining a shared resource management system to facilitate interlibrary lending of materials, providing virtual reference services by library professionals, coordinating access to electronic resource subscriptions, hosting digital image collections from Pennsylvania libraries and other non-profit organizations, providing training to library professionals, maintaining an archive of documentation and other resources for librarians and managing access to all services provided within the POWER Library portal.

Nearly 3,000 Pennsylvania libraries currently participate in the ACCESS PENNSYLVANIA / POWER Library (Pennsylvania Online World of Electronic Resources) program including state-aided public libraries, K-12 school libraries, academic libraries, and other libraries with special collections. In addition, HSLC provides support for interlibrary loan services to PA State Correctional Institutions.

Sites supported included: <u>POWER Library</u>; <u>POWER Kids</u>; and <u>POWER Teens</u>.





A brief summary of important deliverables follows for each of the core services provided.

ACCESS PENNSYLVANIA/Statewide Catalog

- The statewide catalog includes over 800 public, academic, K12 and special collections libraries.
- In FY 22, the statewide catalog was enhanced by adding real-time connection to the Pennsylvania Integrated Library System (PaILS), thereby creating a hybrid catalog with a physical union catalog, and Z39.50 access to the PaILS SPARK consortium.
- Over 9 million titles and 36 million copies are included in the statewide catalog and are available for interlibrary loan from over 800 libraries.
- In FY 2022 over 103,000 title requests were placed and over 87,000 were filled, representing an 85% fulfillment rate.

PA Photos and Documents

- HSLC managed PA Photos and Documents, providing statewide access to digital indexing and access software for the Main POWER Library collection and the Pennsylvania Historical and Museum Commission: Pennsylvania State Archives collections. - POWER Library is currently represented within the PA Digital aggregator (https://padigital.org), which is further harvested into the Digital Library for America (https://dp.la). In FY 2022, harvests by PA Digital occurred in September 2022, December 2022, and March 2023. POWER Library items represent 20-25% of the entire Pennsylvania collection material in DPLA.
- As of June 30, 2023, 94 institutions participated in the service, hosting 335 digital collections, with the PA State Archives posting an additional 586 collections.

Access to E-resources

- HSLC managed authentication for access to e-resource subscriptions that are part of POWER Library, available here: <u>https://powerlibrary.org/e-resources/?all=y</u>
- HSLC continued to grow K12 access to e-resources via Single Sign-on tools, such as Google and Clever. In FY 22 access to ClassLink was added.
- Over 7.5 million items/articles and pages were viewed in POWER Library remote databases.
- HSLC recommended and facilitated the purchase of 350 new eBooks in September 2022 with additional LSTA funds. ProQuest E-Book Central was added to POWER Library which added over 100 titles on diversity, equity, and belonging. 150 EBSCO titles were added on the subjects of STEM, and mental health and wellness. 100 Gale titles were added covering subjects such as diversity and mental health.
- HSLC also conducted a procurement for new e-resources subscriptions for POWER Library. In April 2023, the Office of Commonwealth Libraries requested that HSLC manage the eresource procurement for FY 2023 - FY 2027, since the Gale 5-year contract was due to expire on July 31, 2023. HSLC produced and issued a Request for Proposals (RFP) on May 1, 2023, with responses due by May 31, 2023. The RFP sought proposals for products that matched particular subject needs within the following target audiences: elementary schoolage students; middle/high school students, and the general public.
- In FY 22, HSLC issued an RFP for an e-content platform to offer search term access to e-resources.

Chat with a Librarian

- HSLC managed Chat with a Librarian, Pennsylvania's statewide live virtual reference service, available here: <u>https://powerlibrary.org/chat/</u>
- HSLC administered the program by coordinating the staffing of the service by public and academic librarians. Chat with a Librarians collaborated with 40 institutions that contributed staff time, representing over 330 library locations.
- In FY 2022 the Chat with a Librarian service responded to over 30,000 sessions, via chat, SMS and email.

POWER Library Portal

- The POWER Library portal ties all the services together and makes them available from a single domain: powerlibrary.org.
- In FY 2021, there were over 745,000 visits to the POWER Library, and over 1.2 million pages viewed.
- An accessibility widget added in March 2022 was well used in FY 22. The widget enhances POWER Library web page views with some of the following options: a Screen reader, Contrast options, Dyslexia-friendly tools, Text size options and Text spacing options. The two most popular features used were the Dyslexia Legible fonts and the Increase Contrast for text. The accessibility features were used over 6,400 times.
- HSLC maintained the For Librarians pages, a location for professional support materials at: <u>https://www.powerlibrary.org/librarians/.</u> There were nearly 93,000 page views in the For Librarians section of the portal.

- HSLC maintained a landing page in the POWER Library designed for children in grades PreK-3 at <u>https://kids.powerlibrary.org</u>. There were over 300,000 visits to the POWER Kids web page.
- HSLC maintained a site in the POWER Library designed for intermediate-level students at https://teens.powerlibrary.org. There were nearly 40,000 visits to the POWER Teens web page.



- HSLC offered look-up tool for the public to locate their nearest public library: <u>https://powerlibrary.org/about/find-a-pa-library</u>. This lookup tool was used over 6,700 times in FY22.
